### **Confirmation of Minutes:**

The minutes of the previous meeting held on 14<sup>th</sup> March `2018 which had been circulated vide circular no.: SMTA/Mar.2018/EBM/MIN-04 were read. There being no objection to the same and none on record, the same were taken as confirmed and were adopted.

### **Inclusion/Model approval of Sphygmomanometers and Clinical Thermometers for registration under Weights and Measures :**

The concern regarding the change in stamping duty laws by the Department of Legal Metrology was discussed once again. The matter was discussed in length and it was decided to have a complete understanding of the process from the department concerned which may be discussed with the senior consultants and obtain their legal opinion on the matter before making any representation.

### **MCD Trade License**

MCD has started a drive to challan the shopkeepers who have not yet obtained **MCD Trade Licence**. The SMTA had got in touch with M/S MR Associates who are the authorised agency for collecting documents and fee for the grant of MCD Trade Licence. The Secretary Mr. Puneet Bhasin along with Mr Satish Mahajan met with office bearers of other Associations of Bhagirath Palace to discuss the above matter. Due to ambiguity found on the subject matter, the house decided to hold further talks with the department's senior head to get better clarity and then proceed accordingly.

### **Renewal Of Certificates**

The House discussed and decided that the renewed certificates of recognition should be issued to all the members as the current ones were nearing their expiry. The Secretary apprised the house of the fact that the said certificates were carrying a validity of two years.

The Secretary Mr. Puneet Bhasin, recommended to the house that special Memento of recognition should also be given to the Executives and Office bearers. The said recommendation was appreciated and accepted by the House.

### **Demand for Legal Expenses**

The president Mr. Rajesh Sawhney informed the House that SMTA is a constituent of Apex Chamber of Commerce & Industry of NCT Delhi who have taken up the matters relating to rationalisation of Minimum Wages and to curtail the freshly announced DERC rates affecting our monthly energy bills in the state of Delhi. As the said issues are being represented in Delhi High Court, The confederation has asked for extra contributions to the expenses needed for the legal recourse. The House authorised the President and Secretary to contribute to the cause as per requirement.

### **Other matters**

A request was received from Delhi Electrical Traders Association, Bhagirath palace to attend the meeting with Deputy Commissioner North MCD, Ms Ruchika Katyal regarding removal of encroachment in Bhagirath palace. The House requested Mr.Satish Mahajan and Mr. Arun Sharma to attend the meeting and inform the outcome of the same in the next Executive body meeting.

The secretary told the house that once again a letter was received from M/S Raghav Enterprise, Delhi regarding already decided issue of summer vacation for Bhagirath Palace shop keepers. The matter was discussed and it was decided to write to the said member addressing his grievances and reiterating the fact
