P. (C) No. 10514/2019 and W. P. (C) No. 10478/2020 filed before the Hon'ble High Court of Delhi, and to do all such acts, things, deeds as may be necessary or proper to carry out the purposes mentioned."

"RESOLVED FURTHER THAT the consent of the Executive Body be and is hereby accorded to authorize Mr. Harpreet Singh Bhatia, to appear, sign, verify, declare, affirm, make, present, submit and file all necessary notices, plaints, petitions, written statements, affidavits, undertakings, vakalatnamas, declarations, appeals, revisions, applications, statements, complaints, papers and documents and all proceedings and matters in connection with any suit or proceeding filed by the Association or against the Association before Hon'ble Supreme Court in relation to the said case."

"RESOLVED FURTHER THAT the consent of the Executive Body is hereby accorded to authorize Mr. Harpreet Singh Bhatia, to nominate, appoint and engage advocates, solicitors, counsel or other professionals and retainers and to incur such expenses as may be necessary with regard to the above including payment of fee to solicitor and such other expenses that may be incidental to the above forthe case filed in Hon'ble Supreme Court in relation to the said case."

"RESOLVED FURTHER THAT Mr. Harpreet Singh Bhatia is authorized to do all such acts, things, deeds as may be necessary or proper to give effect to the above resolution."
