GUIDELINES FOR THE ANNUAL AWARDS

UDYOG AWARD :

SHALL BE AWARDED TO A MEMBER FIRM EITHER FOR MANUFACTURING AN IMPORT SUBSTITUTE, THAT TOO OF GOOD QUALITY AND ACCEPTED BY THE PROFESSION OR MAY NOT BE IMPORT SUBSTITUTE, BUT SHOULD BE A NEW INVENTION OR ANY OTHER PRODUCT WHICH HAS BEEN ACCEPTED BY USERS / PROFESSION / TRADE FOR REAL GOOD QUALITY AND IS AN OUTSTANDING PERFORMANCE IN FIELD OF EXPORT OF SURGICAL INSTRUMENTS, MEDICAL EQUIPMENT AND ALLIED PRODUCTS.

ALDERMAN AWARD :

SHALL BE AWARDED TO A SENIOR MEMBER OF THE ASSOCIATION FOR HIS SERVICES AND CONTRIBUTION TO THE ASSOCIATION OR HIS OUTSTANDING ACTIVITIES IN SOCIAL SERVICE ETC.

SARVOTAM SEVA PADAK :

SHALL BE AWARDED TO A MEMBER OF THE EXECUTIVE BODY OR AN OFFICE BEARER WHO HAD CONTRIBUTED / DEVOTED MAXIMUM IN WORKING OF THE EXECUTIVE COMMITTEE AND HELPED EXTRA ORDINARILY IN COMPLETION OF THE TASK OF THE ASSOCIATION DURING THE PERIOD UNDER CONSIDERATION.
