AGENDA ITEM 1 : Welcome Address by the President

AGENDA ITEM 2 : Confirmation of Minutes of Previous Executive Body Meeting

The Minutes of the 4th Executive Body meeting held on 28th March, 2026 were circulated vide circular No SMTA/Mar 2026/EBM/Min-04 dt 30-03-2026 and the same were read by the secretary and there being no objection raised and none on record, the minutes were confirmed and adopted.

Mr Pradeep Chawla also suggested to make the meetings of the Sub Committee under its respective chairman compulsory to six in one year and prepare minutes and submit the same to President / secretary for setting up the agenda for the EBM . It was deliberated that the same may cause excessive workload on the sub committees so should not be made compulsory for the time being .

AGENDA ITEM 3 : To discuss the issue of increase in subscription fees for 2026-27

In continuation of the 4th Executive Body Meeting, the discussion regarding the agenda item on the increase in Admission Fee and Annual Subscription Fee was continued the following day through a Zoom meeting. The following members also joined the discussion:

The proposal to revise the Admission Fee and Annual Subscription of the Association was placed before the Executive Committee. A detailed discussion took place among the Executive Members and Office Bearers, and various suggestions were considered.

After due deliberation, the following resolutions were passed:

“Resolved that the Annual Subscription for the member firms of the Association be and is hereby revised to Rs. 5,000 (Rupees Five Thousand only) per annum with effect from 1st April 2026, with a provision of a 10% discount for members who make the payment within the first three months of the financial year, i.e., on or before 30th June.”

“Further Resolved that the Admission Fee for new members be and is hereby revised to Rs. 20,000 (Rupees Twenty Thousand only) with effect from 1st April 2026.”

“Resolved further that the above revision be placed before the next Annual General Body Meeting for its ratification.”
